

AGREEMENT

BETWEEN THE ESCOLA SUPERIOR DA MAGISTRATURA DO ESTADO DO
CEARÁ

AND

THE CUMBERLAND SCHOOL OF LAW AT SAMFORD UNIVERSITY

WHEREAS, in consideration of the interest exhibited by the Escola Superior da Magistratura do Estado do Ceará, and the Cumberland School of Law at Samford University, Birmingham, Alabama, U.S.A., in participating in exchange and legal educational programs which may be conducted in both Brazil and Birmingham; and

WHEREAS, the Escola Superior da Magistratura do Estado do Ceará, and Professor Dr. Charles D. Cole, Director of International Programs of the Cumberland School of Law, herein agree to develop educational and or exchange programs which will facilitate the visitation by Judges of the Escola Superior da Magistratura do Estado do Ceará, for legal educational programs at the Samford University campus in Birmingham, Alabama and at international study-abroad programs which the University may conduct, and to develop programs of mutual cooperation which will offer the Judges of Escola Superior da Magistratura do Estado do Ceará (hereinafter "Judges") and the Cumberland School of Law at Samford University (hereinafter "Cumberland") the opportunity to become familiar with the legal culture of each of the respective countries; and


WHEREAS, the parties to this agreement herein agree that Cumberland shall develop, pursuant to the mutual agreement of the parties hereto, short-term legal educational programs which will allow the Judges to participate in both on-going legal education programs and specialized programs which may be agreed upon, without payment of tuition for said programs. The parties shall mutually agree upon the duration and nature of such legal educational programs and the number of Judges who will participate on an annual basis. The parties herein recognize, however, that any Judges so participating in any legal education programs agreed upon shall require that the Judges or the Escola Superior da Magistratura do Estado do Ceará obtain funding for travel and general expenses. The Cumberland School of Law shall furnish the opportunity for attendance on an audit basis in the mutually agreed upon courses but shall not be responsible for payment of the travel and general expenses including, but not limited to books necessary for course purposes, of the participating Judges. The Cumberland School of Law at Samford University shall, however, grant a certificate for courses in which the Judges participate upon completion of said courses; and

WHEREAS, the parties to this agreement are desirous of having the Cumberland School of Law present legal education programs for Judges at times mutually agreed upon by the parties in Brazil, it is agreed that the Cumberland School of Law shall provide programs relating to topics mutually agreed upon by the parties herein on such dates and for such duration as the parties may mutually agree. The undersigned parties

further mutually agree that the person or persons selected by the Cumberland School of Law to offer the conferences mutually agreed upon shall offer the conferences without payment other than the reimbursement of travel and living expenses incurred as a result of performance of the program or programs conducted for the Escola Superior da Magistratura do Estado do Ceará as a result of the mutual agreement of the parties.


NOW THEREFORE, the undersigned parties mutually agree to proceed promptly to implement the purpose of this Agreement and establish a working arrangement which will allow representatives of the Escola Superior da Magistratura do Estado do Ceará to visit the legal education programs sponsored by the Cumberland School of Law at Samford University described above and to facilitate conduction of mutually agreed upon educational programs by a person or persons designated by the Cumberland School of Law of Samford University, in Fortaleza, Brazil. The parties hereto further agree that this Agreement will continue year-to-year until such time as either party hereto gives written notice to the other party of the termination of such. The Agreement will cease six months following written notice received by the party notified.

AS EVIDENCE OF THE INTEREST OF THE CUMBERLAND SCHOOL OF LAW TO COOPERATE WITH THE ESCOLA SUPERIOR DA MAGISTRATURA, CUMBERLAND WILL MAKE TWO TUITION SCHOLARSHIPS AVAILABLE TO JUDGES OF THE ESCOLA SUPERIOR SELECTED BY SAID ESCOLA WHO HAVE THE NECESSARY PROFICIENCY IN ENGLISH TO PARTICIPATE IN THE MASTER OF COMPARATIVE LAW PROGRAM CLASSES, WHICH WILL BE CONDUCTED IN ENGLISH, SUCCESSFULLY. THIS OFFER OF TWO TUITION SCHOLARSHIPS IS APPLICABLE TO JUNE AND JULY, 2008 AND MAY BE EXTENDED TO FUTURE YEARS AS THE PARTIES TO THIS AGREEMENT MAY MUTUALLY AGREE.
